Dear Premier and Minister Glavine:

***Request to meet re: Merger of District Health Authorities***

We are writing as a follow-up to our letter of February 14, 2014 in which we, at length, outlined our desire to meet to discuss your Government's proposal to merge District Health Authorities as we understand that your government will bring forward legislation in the fall which would create a Provincial Health Authority.

We received your response of February 21 in which you said that there is a commitment to meet with the leaders of the Health Care Unions as part of Minister Glavine's tour of all the Districts, including the IWK.

However the Minister has been quoted in several of the media and related comments that he intended to meet with the leadership within the next six months. Clearly, given the importance and profile of this matter; these comments or overtures do not reflect a sincere desire or intent to have open and constructive discussions with those who represent the thousands of workers in the Health Care system.

We believe this meeting needs to be arranged sooner rather than later if we are to have or hope to instill confidence in the process.

As the heads of all the public sector health care unions in Nova Scotia, NSGEU, CUPE, NSNU and Unifor, we represent more than 20,000 health care members. Our members - nurses, health care workers, clerical and support staff – want to focus their efforts on delivering front line health care. They do not want to enter into a protracted battle over benefits and the provisions of collective agreements that they have negotiated over several decades.

As reflected in our approach, we take this matter very seriously and we have had two meetings of the health care leadership and urgency of this meeting request was at the top of our agenda. We have enclosed our previous letter and your response for your ready reference. Please contact my office as soon as possible. I am the signatory to this leader of behalf of the healthcare union leadership.
