This agreement made this $\frac{9}{2}$ day of February, 2023

and

Regional Residential Services Society (the "Employer")

WHEREAS a collective agreement is in effect between the Employer and the Union;

AND WHEREAS said collective agreement does not expire until March 31, 2023;

AND WHEREAS the parties are desirous of amending certain provisions of said collective agreement;

NOW THEREFORE, pursuant to Article 31.4 of said collective agreement, the Employer and Union agree to reopen certain provisions of the collective agreement and they shall be amended as expressly provided below:

- 1. Article 31.1 is amended by deleting "March 31, 2023" in two places and replaced with "March 31, 2024"
